KEWANNA TOWN COUNCIL

The Kewanna town council met in regular session Thursday, December 1, at the town hall with the president, Jeff Finke, presiding. Others present were council members Dan Birge and Mark Smith; clerk-treasurer, Jenny Kay; Dennis Price, town marshal; Mike Molitor, town superintendent; Robert Murphy, grant writer; Susan Mahoney, Jon Sailors, Joe Hott and Devon Moore.

The minutes of the November meeting were read and approved.

The monthly fire report was submitted to the council prior to the meeting. It revealed six town responses (one fire and five medical) and 13 township responses (four fire and nine medical). Training involved search and rescue.

Marshal Price submitted his November report and discussed a neighborhood watch program that local resident, Vickie Molitor, had inquired about. The town will look to Akron for information on how to run this program. A reminder will be sent out on the January and February water bills as to when the first meeting will be held. The marshal's monthly report noted three traffic warnings, one criminal arrest, 37 calls answered and 1,110 miles patrolled.

The council hired Shan Jolley to fill a part time deputy slot for the town beginning in January.

Bob Murphy opened the requests for qualifications for architectural engineering service proposals received for the downtown revitalization planning grant. The proposals will be rated by committee members to determine who will be interviewed for the project based on scores.

The council approved the purchase of tires for one of the town's pick-ups from JD's Service Center. The council tabled a request for a new tool box for the truck until a quote is received.

Additional appropriations from the Public Safety fund were approved as advertised.

The town clerk will attend the 2012 IACT clerk-treasurer's workshop in Indianapolis, January 9-11.

The council set a special year-end meeting for 4:30 p.m. Thursday, December 29, 2011, at the town hall.

The town superintendent's monthly report noted repairs to a wheel on the leaf machine.

An old outlet pipe at the town dump site was located by Clifford Bragdon and a 20 foot extension added to it. Over the last year, dirt from various projects was pushed around and covered the outlet. It is hoped the work will help drain the water from the area of the brush pile.

treatment plant to the new irrigator went bad and was replaced by Rex Urbin. He also replaced a control light for one of the irrigator pumps.

Town employees worked at the wastewater treatment plant getting it ready to shut down for the winter. A new piece of pipe was ordered to repair two control valves. Both lagoons were then pumped out and the vactor truck was used to wash and clean the contact tank. The irrigator was then drained and notes made of nozzles that will have to be cleaned.

The Christmas decorations were repaired and hung for the season.

The red pick-up was taken to Logansport for repairs to the transmission.

The mower was power washed, greased, oil added and all filters replaced before being stored for the winter. New blades and belts were ordered for next year.

Assistant superintendent Daniel Van Lake power washed the vactor truck and drained it for winter storage. He started to service the big tractor, cleaned and put away the push mower, weed eater and leaf blower and brought one snow plow into the garage to check it over.

The leaf box was taken off of the dump truck and taken to the garage for cleaning. A new exhaust gasket was installed on the box and they are contemplating painting it. Work was also done on the dump truck to get it ready for snow plowing.

The water works pumped a total of 1,072,100 gallons of water during November.

Claims against the town, water and sewage works were okayed for payment.

The town council met in special session before the regular meeting to receive bids on the town's bucket truck. The truck was sold to Mark Druzbecki of Walkerton.

The town clerk-treasurer is looking for old black and white photos of the Town of Kewanna to hang in the town hall. Persons having photos should take them to her at the town hall.

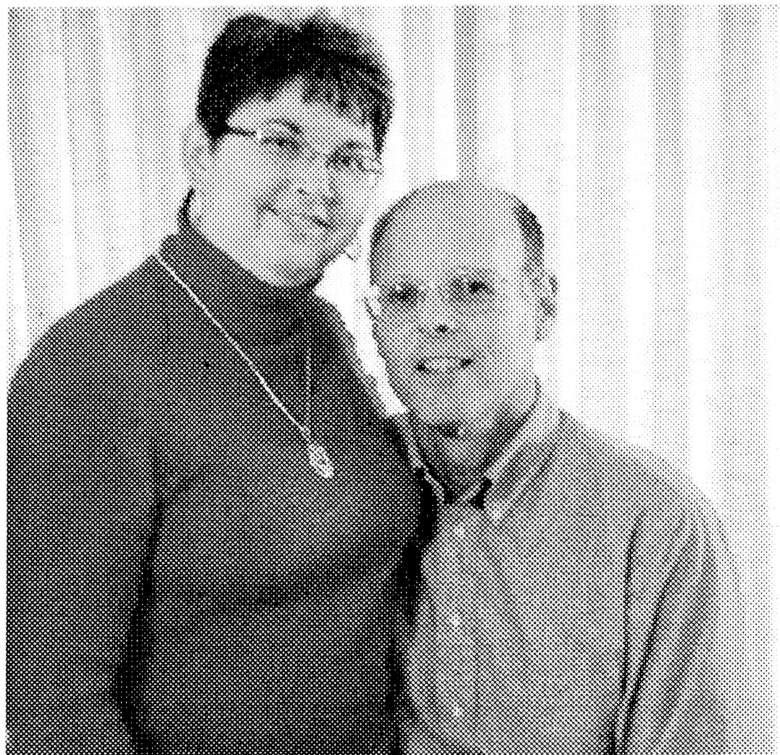

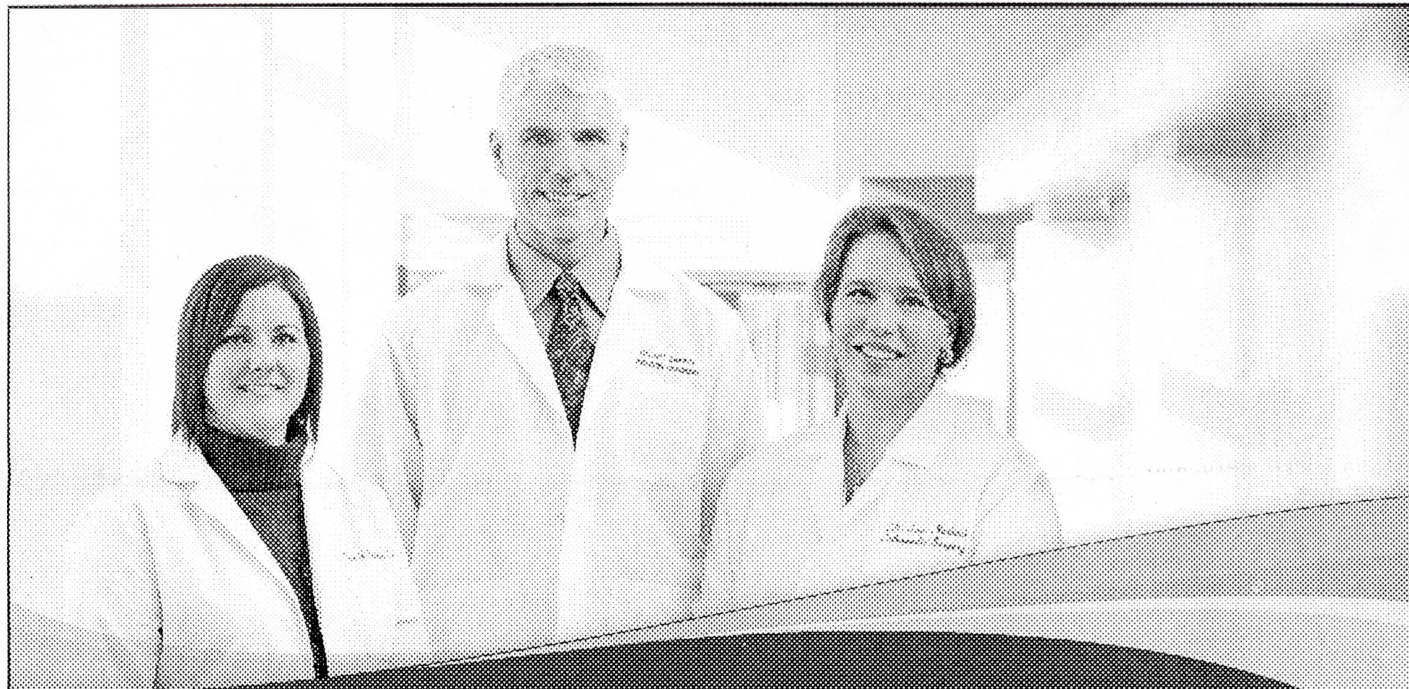

Visiting Mars

My husband recently spent a few days out of town (literally, he was in a forest). He camped in a remote area and experienced poor cell phone reception. I tried calling him, but he didn't answer, nor did he call me. For three days.

For some married couples this would mean little, but I am used to talking to my husband every day. It is customary for him to return my calls. After 20-plus years of marriage, I've come to count on him for little things like a hello. When he didn't reciprocate any communication for 72 hours, my mind began to spin.

A logical person might assume he'd lost cell phone service. A reasonable person would consider that his cell phone battery may be running low, or perhaps his wilderness activities kept him busy and he didn't have time to call. There were a number of logical and reasonable explanations for the situation.

I was not thinking of any of them.

My husband was incommunicado for three days. I started to imagine all the perils possible in his circumstance. A car crash. Lightning strike. I considered the likelihood that he'd lost his phone. Or, perhaps a wild grizzly bear stole it. I contemplated the possibility of his being kidnapped and held

against his will. Maybe he was lying unconscious in the woods - under a downed tree. He might be injured and bleeding and unable to press the answer button on his phone. Perhaps he'd fallen and couldn't get up.

Finally, on the third day, my phone rang. It was him. His voice sounded chipper; not stressed. Healthy; not injured. Alive; not dead.

With a logical tone he told me his remote location prohibited him from dialing out or receiving incoming calls. I felt relieved, and a bit sheepish. I'd let my mind get away from me, thinking of all sorts of negative situations, while my husband hadn't given our inability to communicate a second thought.

It made me aware of our differences and the well-known phrase that begins with, "Men are from Mars." I do believe men might be from Mars, but if that is the case, then women are from the superstore.

Mars has sand and rocks. The superstore has everything else: produce, clothing, pet food, school supplies, home furnishings, toiletries, car parts and a hardware section. I am often called upon to visit the superstore, retrieve multiple items and juggle them while walking toward the cash register. All the while, my husband is on Mars - with its sand and rocks - looking for a TV remote. (Never mind there are no TVs on Mars, my husband

will find a way to get satellite service; just give him a cardboard box, a couple of paper clips and a roll of duct tape.)

The whole Mars-superstore analogy gives us insight into the inner workings of our brains. Men and women are wired differently. We can't change this. It's our lot in life.

Someone told me men are able to focus their thoughts on one thing at a time. They do not get sidetracked by the periphery or distracting ideas about how the laundry needs folding, the dog could use a walk, the coffee is running low and we are down to our last roll of toilet paper.

I cannot imagine thinking of one thing at a time. It is beyond my comprehension, control and ability. My brain attempts to focus on at least 10 items at any given moment - which helps to explain why I visit the superstore and forget what I went there to purchase. I am fragmented.

My husband is not. He sits happily on Mars with his toes in the proverbial sand. When I don't return his phone call he chooses one logical explanation, grabs the remote and takes a nap.

When I try to return his call, he is sleeping and doesn't answer; and my mind starts spinning - again.

Men are from Mars and I am not. Sometimes I wish I were. I'd like to go there some day, just to understand what it is like. After my visit, I'd invite my husband to come with me to the superstore - you know, so he could experience it for himself. Well that, and to give him a chance to practice his juggling.

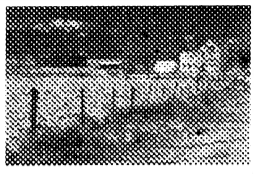
