

Grass Creek church to celebrate centennial

The Grass Creek United Methodist Church will celebrate its 100th year of existence October 30. Sunday, The original church was organized as a United Brethren congregation in 1875 and met in a district schoolhouse until the first church was built at Round Lake Cemetery.

In October of 1910, the cornerstone was laid for a new church building in Grass Creek, a town which had developed after the completion of the railroad from Logansport to Culver in 1883. Rev. J. D. Coverstone was the pastor and dedication took place on September 9, 1911. The new church was built at a cost of \$7,100. In 1946 the church merged with the Evangelical Church (Evangelical United Brethren) and in 1968 united with the Methodist Church to become a part of the United Methodist denomination.

On Sunday, October 30, the regular Sunday school classes will start at 9:30 a.m. followed by a worship service at 10:30 a.m. with Pastor Jan Moyer. The Ladies Aid will serve lunch at noon with an afternoon program beginning at 1 p.m. featuring "Soldiers Again", a men's vocal group and words from former pastors and members.

Everyone is invited to attend all or part of the centennial celebration.








Class of '31 Holds Reunion

Ban barrel burning

The household trash we burn today is unlike what grandpa burned in his barrel of yesteryear. Today, burning about 10 pounds of trash in a burn barrel may produce as much air pollution as a modern incinerator burning 400,000 pounds of trash. Dioxins, furans, chromium, benzene, hydrocarbons, cyanide, chloride, cadmium, arsenic and mercury are chemicals that go into the air when household trash is burned. These chemicals pose a significant health risk and public nuisance.

It is estimated that one in five resident households have burn barrels in Kewanna. Why should the majority have to breathe the toxic air pollution of the minority? So many times, trash is burned and left to smolder allowing the stench to 'trespass' onto the neighbors, diminishing their enjoyment of life and property. 

REQUEST FOR QUALIFICATIONS FOR ARCHITECTURAL ENGINEERING SERVICES

This is a request for qualifications to provide professional architectural engineering services for a Community Focus Fund Planning Grant that will be applied for by the Town of Kewanna for the purpose of completing a Downtown Revitalization Plan.

The Architect/Engineer selected will be responsible to: 1) Evaluate the downtown infrastructure; 2) Identify problems with sidewalks, curbs, and gutters; 3) Identify any inadequacy of utilities in the downtown area; 4) Identify street lighting problems, including the condition of existing lights and inventory; 5) Identify parking issues and inventory; 6) Inventory and evaluate street signage; 7) Evaluate the handicapped accessibility of the downtown including wheelchair ramps, drives, and streets; 8) Evaluate street furniture and landscaping; 9) Evaluate vehicle circulation and pedestrian access; 10) Evaluate the condition of each building and Façade for safety and deficiencies; 11) Evaluate each building in the downtown separately and prepare a deficiency list including condition of: windows, doors, store fronts, brick, stone, and electrical; 12) Evaluate open building lots and open spaces, why they are open, and if they are available for use; 13) Identify any local economic development finances that can be identified; 14) List annual events (fish fries, festivals, civic events) including size and attendance over the years; 15) Prepare an infrastructure improvement plan; 16) Prepare a building improvement plan; 17) Prepare a plan identifying potential businesses needed in Kewanna as identified by the residents.

The Plan will identify goals, and explain the objectives of each goal. The report will include an implementation plan and a maintenance plan for each area. A budget for each area will be identified. A cost estimate/budget will be included for each area. The plan shall include a schedule and budget, and shall identify overlap areas when scopes of work either conflict, or are complimentary. The plan will include all potential financing mechanisms.

A separate chapter of the document shall be dedicated to summarizing what process was followed and shall contain the meeting dates, sign in sheets, minutes and other details necessary for historical documentation:

The Architect/Engineer should assume the audience is neither technically trained nor familiar with the history of the project. Should implementation not occur immediately, future community leaders should be able to read this document and understand the situation and what had been considered. This product should provide historical documentation for the community's files;

Prepare the preliminary detailed cost estimate for all options sufficient to aid the community in making decisions, including preliminary rate impact on the users and funding scenarios assuming different grant amounts or funding sources and identifying all potential funding sources and financial assistance available;

Prepare an Executive Summary at the beginning of the report summarizing the description of the issues leading to the study, the discussion of the alternatives, the recommended actions, and cost estimates.

In order to be considered, qualifications must be submitted to Jenny Kay, Clerk-Treasurer, at the Kewanna Town Hall, 308 South Logan Street, Kewanna, Indiana, 46939, no later than 4:00 P.M. on December 1, 2011. The Town of Kewanna reserves the right to reject any or all qualifications. All qualifications should be sealed and marked on the envelope: DOWNTOWN ARCHITECTURAL ENGINEERING PLANNING QUALIFICATIONS".

Qualifications will be opened at 7:00 P.M. on December 1, 2011 and read aloud. The qualifications will be reviewed by the Downtown Committee and additional information may be requested from submitting firms. Interviews will be scheduled, at a date to be announced, for firms on the short list to be determined by the Downtown Committee. The Town will negotiate fees with the successful firm. The contract will be awarded to the most reasonable, responsible, and responsive offeror whose qualifications are determined to be the most advantageous to the Town all factors considered after receipt of the CFF Planning Grant. SCOPE OF SERVICES:




