#### Redbud Trail Rendezvous this weekend

The 21st annual Redbud Trail Rendezvous will take place this weekend, April 30 and May 1, on the Fulton County Historical Society grounds north of Rochester. The event portrays frontier history with tepees and historic tents and camps, foods cooked over wood fires, music and dance on the Chippeway Village stage, 40 wooden booths, muzzle loading shoots, traditional crafts and blanket trading. The festival is named for the redbud trees that bloom on the banks of the river. The event is handicap accessible. Hours are 10 a.m. to 5 p.m. Saturday and 10 a.m. to 4 p.m. Sunday. Admission is \$3 for adults (age 12 and over); \$1 for children 6-11; and free for those age 5 and under.

You should also be sure that your address is correct so the postal department can deliver your statement.





1st Lt. (Ret.) Jeanne Anne Urbin Markle, R.N. Oct. 28, 1943-May 26, 2009

lst Lt. (Ret.) Jeanne Anne Urbin Markle, R.N., a heroic army nurse who served her country during the Vietnam War, arrived at her final resting place Tuesday. This hometown heroine was honored with military rites at the Arlington National Cemetery Columbarium in Arlington, Virginia, on April 26<sup>th</sup> at 3:00 p.m. Entombment followed the ceremony led by Chaplain Hernandez. The honor's team band played, three volleys were fired, then taps were played, following the arrival of the escorted caisson.

Jeanne Anne was an ordinary girl that enjoyed extraordinary life. She was born on October 28, 1943 in Logansport to John W. and Ruth Nellans Urbin. She enjoyed her childhood growing up with three sisters, Janet, Jill, and Joy and brother, Jack. In 1961 she graduated from Kewanna High School. Fulfilling her dream of becoming a nurse and helping others, she graduated with a degree as a registered nurse in 1965 from St. Elizabeth's Hospital in Lafayette.

Ft. Collins, Colorado, was the setting of her first military stint and the locale in which she met the love of her life and best friend, Brian Cody Markle. Following a brief courtship they were married in the Kewanna United Methodist Church on August 6, 1966.

In December of 1966, with great passion for serving her country and to be near the side of her husband, she and Brian

embarked together to their location of deployment with the 24th EVAC Long Binh Hospital, Post - Op # 3 in the Republic of Vietnam. They were the only known husband and wife team to serve together. Both once joked that they were honeymooning in Vietnam.

Jeanne Anne saved many lives while nursing countless troops following their surgeries to repair wounds suffered during their war time service. In the face of great adversity and tragedy, she persevered even though working 12-hour days, the results of the battlefield coming into her arms. surgery suite where she and her colleagues worked was housed in a modest Quonset hut with eight surgery tables and eight surgery teams working simultaneously. The ward she managed had 33 beds.

More recently, Jeanne Anne coauthored three inspiring books detailing the voices of war and stories she'd experienced on the front lines and from the home front. Jeanne Anne leaves behind a powerful legacy of patriotism, honor, courage, and compassion for mankind and our country for her three children and seven grandchildren to remember her by, along with all of her nieces, nephews and great- nephews and greatnieces, all who cherished and adored her.

Family members in attendance at the ceremony were her husband Lt. Col. (Ret.) Brian Markle. two sons, Patrick Markle and Jeremy Markle and wife, Nicole; a granddaughter, Gillian Markle; three sisters, Janet Rae Burkett and husband Jerry, Jill Leazenby, Troutman and her husband Dr. Thomas, and her brother, Jack Urbin. Also attending were a niece, Jeralyn Hines, and two nephews, Jay L. Burkett and his wife, Robin Koch, and David Leazenby. Many friends she had cultivated along life's journey also were present to celebrate her life and recollect memories of the good times they shared. +++++





# Rep. Gutwein: Continuing to Expand on Education Opportunities

In a rare joint announcement, House Speaker Brian Bosma (R-Indianapolis) along with Senate President Pro Tempore David Long (R-Fort Wayne) and Governor Mitch Daniels announced their support for an additional \$150 million investment in K-12 education emphasizing early learning opportunities for Hoosier students.

The announcement came prior to the Revenue Forecast Technical Committee meeting. The updated revenue forecast predicts Indiana will receive more than what was previously expected.

"We were responsible about living within our means and by doing so, K-12 education will now begin to benefit from that fiscal integrity," said Rep.

#### Douglas Gutwein (R Francesville).

The increased revenues in addition to prudent reserve balances prove that the disciplined financial efforts by Republicans in the General Assembly and the governor are paying off for the State of Indiana.

Education currently makes-up

more than 50 percent of the state's budget, and a portion of K-12 education was cut in 2009 due to fiscal revenue being severely low.

While Indiana carefully begins to increase funding for education, many other states across the nation have had to continue to make dramatic cuts to education funding. In Ohio, South Dakota, Florida and Pennsylvania, funding for K-12 education was cut by 10 percent. Even though the \$150 million increase is not fully restoring the cuts that were made, due to the unknown financial climate the

need to be prudent. Education is the only area in the state budget that will now show an increase in funding.

Speaker stated there is still a

A quarter of the \$150 million will be used to complete the extension of full-day kindergarten to every school district in the state. A smaller fund will go toward a "teacher excellence" fund, which will reward teachers through pay based on performance, not seniority.

"Teachers play an important role in a child's development," said Rep. Gutwein. "They should be rewarded for making a positive impact on educational

#### development."

"Our Caucus' core value continues to be fiscal integrity. Because of that primary goal we are able to forward our commitment to K-12 education and put an emphasis on early education," said Speaker Bosma.



Questions & Answers About Our Environment

Dear EarthTalk: Why don't cleaning products have to list their ingredients, and are these products tested for what they might do to your health? -- Patricia Greenville, Bethel, CT Since cleaning products aren't food, beverages or drugs meant

food, beverages or drugs meant to be ingested, they aren't regulated, per se, by the U.S. Food and Drug Administration. However, makers are required by the U.S. Environmental Protection Agency (EPA) to list ingredients that are active disinfectants or potentially harmful. Otherwise, they usually keep their other ingredients secret, presumably so competitors can't copy their formulas.

But consumer advocate Sloan Barnett, author of Green Goes with Everything, doesn't give manufacturers the benefit of that doubt. "Call me suspicious, but I honestly don't think it's because the recipe is top secret," she says. "If it was, there wouldn't be so many competing products with identical ingredients." Barnett thinks manufacturers don't want to scare off consumers by disclosing how potentially harmful many chemicals are flying under the EPA's radar in their products.

"The government only requires companies to list 'chemicals of known concern' on their labels. The key word here is 'known'," she says. "The fact is that the government has no idea whether most of the chemicals used in everyday cleaning products are safe because it doesn't test them, and it doesn't require manufacturers to test them either."

She adds that the EPA, under the terms of 1976's Toxic Substances Control Act, "can't require chemical companies to prove the safety of their products unless the agency itself can show that the product poses a health risk—which the EPA

does not have the resources to do since, according to one estimate, it receives some two thousand new applications for approval every year." She cites a recent study by the non-profit Environmental Working Group, which found that the EPA approved most applications within three weeks even though more than half provided no information on toxicity whatsoever.

Regardless, consumers should

be familiar with what warning labels are on cleaning products. "All household cleaners that contain known hazardous chemicals must carry a warning label that spells out potential risks, along with precautionary steps and first-aid instructions,' reports Consumer Reports' Greener Choices website. manufacturers Some are beginning to be more about their transparent ingredients. The Company, for example, one of the largest manufacturers of cleaning products, now publishes full lists of the ingredients for all of its brands on its corporate responsibility website, CloroxCSR.com. Many praise Clorox for doing so; others argue that, whether or not ingredients are disclosed, the company—like many others—is still in the business of making products that pose health and environmental hazards.

Generally speaking, if you're looking for safer alternatives, browse the cleaning products sections of natural foods markets such as Whole Foods, which are populated with lesser-known but more green-friendly brands. For do-it-yourselfers, the Greener Choices website also lists recipes for eco- and healthfriendly homemade household cleaners using ingredients like baking soda, borax, lemon juice vinegar. and CONTACTS: Greener Choices, www.greenerchoices.org; Clorox,

# Time to file 2011 personal property forms

Personal property returns are to be filed between March 1 and May 16. Failure to file a return by May 16, as required by law, will result in penalties. It is no longer the duty of the township trustees to assist with the filing of personal property returns. If you filed a business return (Form 103-L or 103-S) or a farm return (Form 102) last year, you will need to file the return this year at the Fulton County Assessor's office located in the Fulton County Office Building, 125 E. 9th Street, Suite 206, Rochester, You need to turn in any new equipment you have acquired or any equipment that is no longer used for your business so that it can be taken off your equipment

Personal property forms can be picked up at the Fulton County Assessor's office, all local libraries in the county, the Fulton County Historical Society museum and the Kewanna town hall. Forms are also available from the State website at www.in.gov/dlgf.



#### Indiana Law **Enforcement Agencies Increase Speed Patrols**

Federal grant award helps make additional efforts possible

In an effort to reduce the number of speed-related deaths injuries on Hoosier roadways, the Indiana Criminal Justice Institute (ICJI) has awarded Dangerous Driving Enforcement (DDE) grants to 29 local law enforcement agencies, including the Indiana State Police, to aggressively target speeding motorists.

Motorists can expect to see a greater police presence on roadways beginning this month,

participating agencies increase their efforts to target and ticket motorists who drive above posted speed limits. While speed enforcement is a year-round priority, many law enforcement agencies will be stepping up their efforts over the coming weeks.

In 2010, 18 percent of fatalities and 12 percent of injuries sustained in Indiana traffic collisions involved speed. In fact, nearly 10 percent of all collisions that occurred in Indiana involved a driver who was speeding.
