Kewanna Fall Festival, Sept. 24- 26

The annual Kewanna Fall Festival, presented by Kewanna H.E.A.R.T., will run Sept. 24, 25 and 26. Corporate sponsors of the event are the Community State Bank, Kewanna Metal Specialties and Winamac Coil Spring, along with support from the Fulton County Community Foundation and the REMC Operation Roundup Trust.

The festival will kick off at 4 p.m. Friday, Sept. 24, with a free circus at 4 p.m. Youngsters can enjoy free carnival rides from 4:30 to 8 p.m. These rides are sponsored by WROI Radio, North Central Co-op (Kewanna branch), Harrison-Metzger & Rans Funeral Homes, The Observer, the Rochester Sale Barn, and Black Gold.

An antique tractor show hosted by the Fulton County Historical Power Association will run from 5 to 10 p.m. The Nightshift Band, sponsored by Geiger Excavating, will perform at 5 p.m. and 7 p.m. on the NIPSCO stage.

The Indiana Pacers Fan Van will be on hand from 5:30 to 8:30 p.m. at Phillips and Logan Streets near the park. A mush ball tournament will commence at 6 p.m. at the ball park. There will be a hot dog eating contest at 6 p.m. on the NIPSCO stage, sponsored by Woof, Inc. and the Leiters Ford Tavern. This will be followed by a kiss the pig contest. There will be another free circus performance at 7 p.m. and Quintan Flagg will perform at 8 p.m., sponsored by Carol Hickle in memory of Howard and Brad Hickle.

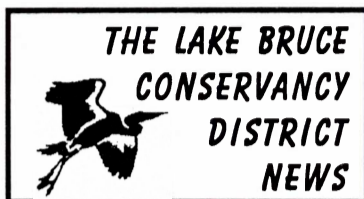

The Lake Bruce Conservancy District held its regular meeting August 12 in the community room of the Kewanna-Union Township Fire Station. All directors were present, along with five freeholders and two guests.

After the reading and approval of the minutes and the treasurer's reports, Josh Estelle from Pfenninger Insurance gave a summary of the district's insurance policy. This policy covers any buildings and business personal property. There are also directors' and officers' liability policies.

The board reviewed and paid the regular utility bills as well as Chris Pine for mowing and Clark Aquatic Services for weed treatment.

The directors received an invitation to join the Association of Indiana Conservancy Districts. This group can help with any questions or problems that the district might come across. A motion was made and passed to join.

Under old business, the district's attorney has written a letter to a freeholder for non-compliance in the hook-up of his property. The property owner is being fined \$2,500 and has been given 10 days to submit a compliance schedule. Failure to do so could result in a court action. The attorney will also be drafting a letter to the Board of Health concerning another freeholder who has yet to hook up.

Director Kathy Fisher reported that the dredging project is now completed with the tear down of the dewatering basin and the sign-off on the property.

The landscaping at the wastewater treatment plant is on hold until the extreme weather breaks.

Directors Gerald Porter and Paul Bradley installed the crane at the treatment plant last month.

Under new business, Richard Denney, plant operator, reported that there were no violations at the plant during the past month. He noted that something will have to be done about the old sludge in the aerator. He was given permission to purchase whatever is needed to run the plant.

Inspector Paul Bradley reported that he issued one permit for a hook up.

The weeds have not made a comeback in the lake so far. If they do, there are funds left to do some spot treatment.

The district voted to charge \$35 for a bad check.

There was a second and final reading of the 2011 budget and it was passed.

The directors' next meeting will be Thursday, October 14, in the community room of the Kewanna-Union Township Fire Station.

Born September 2, 1948, in Logansport, she was the daughter of Russell and Lauramay Wandry Koebecke. She grew up on the family farm with her older brothers, Larry and Walter.

As a proud Indian, Colleen graduated from Kewanna High School with the class of 1966. Illustrating her sense of humor, Colleen bequeathed the following as a senior in the school yearbook, "I leave nothing to no one because I am stingy." When the girls were growing up, summertime brought many wonderful memories of catching rays, cooling down with the sprinkler, some shopping trips for back to school and of course, sleeping in. During the academic year, the "house rules" were employed and adhered to diligently.

Looking Back

Metzger recalls when he was one of "the boys of summer"

KHS graduate and Kewanna native, Don Metzger, has fond memories of his years as one of "the boys of summer". Even though baseball is still a national past time, many local parks do not see as much baseball and softball as they once did, especially during World War II. Money was tight with many bread earners on foreign battlefields, but families could find cheap entertainment at the local ball parks.

Don recalls one game in particular in which he was involved, that being September 19, 1943, when his team squared-off against the Bunker Hill Naval Air Station. The roster for the naval team included baseball legends Ted Williams and John Pesky, who played left field and short stop, respectively, for the Boston Red Sox.

Several major league players left baseball during the war years. Williams and Pesky, Bob Feller and Joe DiMaggio, to name a few, answered their country's call to defend the red, white and blue. During their time in the military, these stars often took part in an occasional ball game or two.

Such was the case when the Bunker Hill Naval Air Station team played the combined Eagles-Roofers team at Riverside Park in Logansport. Metzger played left field for Logansport and went three for four at the plate. Williams, the American League batting champion, was two for four. Pesky, was 0-5. The naval team defeated the Eagles-Roofers, 4-1. However, the Logansport team kept the Navy scoreless through the fifth inning, out hitting them 11-3.

The Eagles-Roofers lone run came in the first inning on a double by the short stop, a

single by the second baseman, and a single by Metzger.

Don noted that he was invited to tryout for the Chicago White Sox, but being a recently married man he chose to pursue other endeavors that would keep him home with his wife and future family.

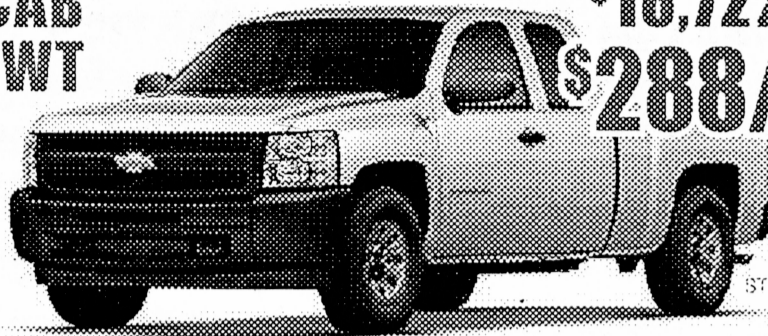

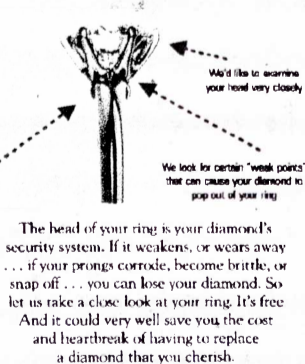

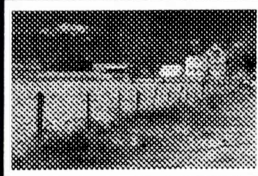
