

History walks the streets at Trail of Courage, Sept. 19&20

You can step back in time to an entirely different life at the 34th annual Trail of Courage Living History Festival, September 19 and 20, at Rochester. The Potawatomi Indians were file down marched single Main Street Rochester's September 5, 1938, on the forced removal known as the Trail of Death. Since 1976, this festival honored the American has Indians and shown life before the removal when this was still Potawatomi territory.

Frontier Indiana comes alive with foods cooked over wood fires, period music and dance, traditional crafts, historic camps and trading, canoe rides on the river and much more. The festival is produced by the Fulton County Historical Society. This event combines genealogy of the Potawatomi Indians and the settlers who lived in Fulton County and northern Indiana in the early 1800s with the rendezvous events, stage programs and the historic canoe landing and fur trade skit on the Tippecanoe River. The Trail of Courage will be held on the FCHS grounds four miles north of Rochester on U.S. 31. Admission is \$6 for adults, \$2 for children (6 through 11), and free for those age five and under. Hours are 10 a.m. to 6 p.m. Saturday and 10 a.m. to 4 p.m. Sunday.

This year's honored Potawatomi family will be descendants of We-wis-wa. Eddie Joe Mitchell, Prairie Band Potawatomi, Mayetta, Kansas, and other family members will tell their story at 10:30 a.m. on the Chippeway Village stage both days.

Returning this year will be the River Valley Colonials Fife & Prairie, Drum Corp. Sun Wisconsin; a Ben Franklin portrayal by Chuck Molenda, Carpentersville, Illinois; and a Johnny Appleseed portrayal by Steve McPhail, Upland.

a Woodland Indian wigwam village. A special re-creation of a Miami Village includes wigwams and life ways demonstrations, such as making cattail mats. There is also a re-creation of Chippeway, the first trading post, post office and village in Fulton County in 1832. Food purveyors and traditional craftsmen set up in wooden booths to demonstrate and sell their wares. Craftsmen also sell pre-1840 trade goods from blankets and in historic merchant tents, offering a variety of items from clothing and jewelry to knives and candles, everything needed to live in frontier days. Canoe rides, muzzle loading shooting and tomahawk throwing contests and a frontier blab school add to the frontier activities.

Two stages with frontier music and dance present programs from 10 a.m. to 5 p.m. Saturday and 10 a.m. to 4 p.m. Sunday. Since the early 1980s, FCHS has received grants from the Indiana Arts Commission and the National Endowment for the Arts to help pay for musicians and dancers including the 42nd Royal Highlanders, River Valley Colonials Fife & Drum Corp, Aztec dancers, Shakin' Hammers String Band, Mark and Lisa Steve McPhail Woolever, (Johnny Appleseed), Chuck Molenda (Ben Franklin), Shirley Needham with her red-tailed and red shoulder hawks, Chief White Eagle and his Indian lore, and Indian dancers and drum. Many volunteers provide programs such as the Frontier Frolic dance called by Shirley Willard, Nan Edwards and her dogs pulling travois, Marsha Glassburn with her Indian storytelling, the Riddle School 4th grade dancers, and Mark Gropp and his bagpipes. Both Catholic and Protestant worship services are held at 9 a.m. on Sunday.

Pioneer foods are cooked over wood fires. Visitors can feast on buffalo burgers, chicken and noodles, barbecue, ham and beans, and fish and chips cooked in big iron kettles, potato brats, apple dumplings, corn on the cob, apple sausage and more. including ice cream, one of returned to: Tom Mate, Box 96, George Washington's favorite Kewanna, IN 46939 or dropped treats. Local clubs cook and serve these historic foods to fund their projects including Rotary, Kappa Delta Phi, Swingin' Dudes Square Dancers, Grass Creek Lions Club, and the Fulton County Historical Society. The Jackson family of rural Rochester offers barbecue and sweet potato pie and also exhibits a frontier African-American house. Many people attend the festival just for the delicious food. The grounds are handicap accessible. Free tram rides are available to bring people from the museum, round barn and Living History Village at the north end of the grounds to the festival site. The museum and village are open with costumed hosts and free admission.



Persons applying to receive a Christmas basket must provide a photo ID, birth certificate for each child living with them, proof of residency and a phone number where they can be reached.





For many communities, board meetings are announced before and after the meetings telling what is discussed, proposed and acted upon. In some cases minutes are posted in news media. The Union Township Public Library has held meetings and executive sessions in silence for a long time. The prevailing attitude is that if you want to know anything, come to the meetings and find out for yourself. Do you know when and where meetings are held? Do you know your board members?

I have learned that the library board purchased the old doctor's building for storage around two years ago at a price of \$40,000. That amount came from the Rainy Day Fund saved up by the library over many years. At this time the library board intends to tear down that building. The current board is convinced that the building is not repairable or useful. OUCH! Will you pay me \$40,000 for my house and tear it down, please? Did you hear about the 1st hearing that was held to agree to tear down the building and expand to that side and the rear of the present library? I didn't either, but the second and final public meeting is to be held to satisfy the requirements that the public be given a chance to respond.

Did you know that over 300 signatures were collected at the

firemen's annual pancake and sausage breakfast to show that the public was aware of the proposed expansion and subsequent changes? As I recall, you did not have to be from here, agree, or disagree with the expansion. You just had to sign that you were

AWARE of the plans. Many signatures were from out-oftowners. Now, at least 300 people are AWARE of this project, even if it is not those of us that use the library and live here.

Did you know that the position of public library board member is a non paid position of a non profit organization? Which means, that you re not supposed to profit from you position? Why is a voting member of this board also a paid employee/contractor to the library? Is that a conflict of interest, or common business practice in a small town? Can I hire myself, too?

Did you know that the grant to do all this has not been approved, in fact the application has not been presented yet? Where will all the books and equipment be stored while you knock down two sides of the building and expand. How long will it take to complete the project? What temporary measures will be available to library patrons? Is it possible to repair and use the "old building" while expanding? Then sell the property later? Perhaps such a plan could recoup funds the library needs to move into the future?

How much more staff will be required to run the expansion? How will this impact our local

taxes? How much will be paid from taxes, grants, bonds, or indebtedness? If we expand using a grant, can we afford to operate the facility? I knew a person who had a Corvette once. They could afford the payments, but could not afford the insurance or plates to drive that Corvette. We are a very small community with many old buildings already gone.

Now, I have done my duty as a concerned citizen asking that the public library patrons give their input on their library and how it is to be run. Please, it takes all of us being heard to see the best changes for all as we get more involved in the business of what That's Kewanna. community is about.

Indiana is fortunate not to be among states faced with releasing convicts early, closing prisons or reducing guards, says Sen. Randy Head (R-Logansport), a member of the Senate Committee on Corrections, Criminal and Civil Matters.

Indiana is one of the few states maintaining funding for corrections this year, according to a recent survey by the Vera Institute of Justice.

Head said analysis showed a least 23 states slashed funding for corrections to help balance their books. Indiana was among 10 states that had not cut cor-

"Hoosiers are very fortunate that they do not have to worry about early-released prisoners roaming our streets," Head said. "I'm thankful our state leaders are able to maintain funds for our prisons and avoid the type decisions made elsewhere that I believe may well put public safety at risk."

Because of the lingering national recession, Head said many states have taken drastic measures in their battles with budgets:

In California, a judge has ordered early release of 40,000 inmates - about 27 percent of the state's prison population within the next two years to ease dangerous overcrowding. Illinois is reportedly considering the same strategy;

Seven states - Colorado, Kansas, Michigan, New Jersey, New York, North Carolina and Washington - have decided to close prisons;

Illinois officials announced recently a \$1 billion costcutting plan means layoffs for more than 1,000 state prison workers:

Oregon lawmakers delayed a voter-approved plan to hand down longer prison sentences for property crimes, because the state couldn't afford it;

Kansas eliminated 85 percent of slots in its substance-abuse treatment program for inmates, citing budget constraints; and

Six states cut funding for corrections by more than 10 percent: Georgia, Idaho, Kansas, Montana, Nebraska and Washington.

Head supported a new twoyear Indiana budget in part, because it maintained funding levels for corrections, was balanced and included no tax increases.


