The regular monthly meeting of the Lake Bruce Conservancy District was held September 10 in the community room of the Kewanna-Union Township Fire Station with all five directors present as well as nine freeholders and one guest.

The minutes and the treasurer's reports were read and approved.

Chairman Gerald Porter listed all of the correspondence since the last meeting.

Director Kathy Fisher reported that the dredging is still going on. The dredger still needs to go at a slow pace because of the lily pads, but he is doing a very good job. He has completed the far east channel and is about half way done with the lateral channel running along the edge of South Park Road.

Buckeye Power has requited their bid for generator maintenance and is now the low bidder. Director Don Morning has talked to someone about doing this work, but has not gotten back with him. The district needs to find out what qualifications they will need to do the job.

The situation with a foreclosure from which the conservancy did not get past due money has been resolved. Richard Denny will ask Monterey how it handles its foreclosures.

Director Brad Glasson reported that the 811 number will be in place as of September 21. This is the number you will need to call before you dig to locate conservancy district sewer lines. Remember, call before you dig!

The original sewer project is now officially closed. All connections made after August 31, 2009, will be treated as a new connection at a cost of \$6,300.

Richard Denny, wastewater treatment plant operator, reported that things are going great. The district had no violations for the month of August. Denny is doing his own testing with equipment the district purchased in conjunction with Monterey. This will result in great savings to the district.

Paul Bradley, inspector for sewer hook-ups, reported that as of now there are 211 homes hooked up and running. There are still 16 not hooked up. This information was forwarded to the Fulton County Board of Health.

Treasurer Rick Tompos reported that the district is 21 units short on receiving money on its EDU. This, along with reviewing the maintenance costs, will mean an increase in the sewer bills. There will be a first reading on the increase next month with a second one in November. It will be adopted at the November meeting.

Walk through history at Trail of Courage Sept. 19-20, 2009

There's history in the wind here. Red-tailed hawks circle over head, nuts fall on the tin-roofed booths and cabins, Indian flute music floats on the breeze.

Take a walk through history at the 34th annual Trail of Courage Living History Festival Sept. 19-20 at Rochester. The Potawatomi Indians were marched single file down Rochester's Main Street September 5, 1838, on the forced removal known as the Trail of Death. Since 1976 this festival has honored the American Indians and shown life before the removal when this was still Potawatomi Territory.

The Trail of Courage will be held at the FCHS grounds four miles north of Rochester on US 31. Admission is \$6 for adults, \$2 for children (6 through 11), and free age 5 and under. Hours are Sat. 10 a.m. to 6 p.m. and Sun. 10 a.m. to 4 p.m.

Frontier Indiana comes alive with foods cooked over wood fires, period music and dance, traditional crafts, historic camps and trading, canoe rides on the river, and much more. It is produced by the Fulton County Historical Society. This event combines genealogy of the Potawatomi Indians and the settlers who lived in Fulton County and northern Indiana in the early 1800s with the rendezvous events and stage programs and the historic canoe landing and fur trade skit on the Tippecanoe River.

This year's honored Potawatomi family will be descendants of We-wis-wa. Eddie Joe Mitchell,

Prairie Band Potawatomi, Mayetta, Kansas, and other family members will tell their story at 10:30 a.m. on the Chippeway Village stage both days. Sherry Futton, County Commissioner, will present a key to the County to them on Saturday during Opening Ceremonies at 10 a.m.

New this year will be River Valley Colonials Fife & Drum Corp, Sun Prairie, Wisc.; McCartney Militia, Allegan, Mich. - Revolutionary War cannon; Shirley Kern Needham with wild hawks, Rochester; Joan McClellan and family, Rochester - Indian tacos and fry bread: Mike Floyd, Logansport, Eel River Tribe history; Norman Rhoads, Plymouth, Spirit of Many Waters - long house; and several new crafts such as Tim Guy, Huntington - Forks of the Wabash bowlwright, and Dave Short, South Bend, flintknapping and traditional tool working. Over 40 craftsmen will demonstrate and sell their wares. Dr. John Haste, Argos, will bring horses this year.

The public is invited to join in the Indian dances from 2:00 to 3:00 p.m., which are held in an arena semi-circled by teepees. The drum will be Massassagan Drum led by Mike Floyd, Chief of the Eel River Tribe. Head dancers will be Bonita Bent-Nelson and Doyle Blooding, South Bend; both are members of the National Center for Great Lakes Native American Culture. George Godfrey, Athens, Illinois, member of the Citizen Potawatomi Nation, will act as emcee. He is president of the Potawatomi Trail of Death Association, and has been dancing at the Trail of Courage

since 1988. Godfrey had an ancestor on the 1838 Trail of Death.

The Trail of Courage includes historic encampments representing the French & Indian War, Voyageurs, Revolutionary War, War of 1812, Western Fur Trade, Plains Indians teepees, and Woodland Indian wigwam village. A special re-creation of a Miami Village includes wigwams and lifeways demonstrations, such as making cattail mats.

Another re-creation is of Chippeway, the first trading post. post office and village in Fulton County in 1832. Food purveyors and traditional craftsmen set up in wooden booths. Craftsmen also sell pre-1840 trade goods from blankets and in historic merchant tents, offering a variety of items from clothing and jewelry to knives and candles, everything needed to live in frontier days. Canoe rides, muzzle loading shooting and tomahawk throwing contests, and a frontier blab school add to the frontier activities.



volunteers provide Many programs such as Frontier Frolic dance called by Shirley Willard, Nan Edwards and Margo Moore's dogs pulling travois, Marsha Glassburn - Indian storytelling, and Riddle School 4th grade dancers, Shirley Kern Needham red-tailed and red shoulder hawks; Mark Gropp - bagpipes. Both Catholic and Protestant worship services are held at 9:00 a.m. on Sunday.

Pioneer foods are cooked over wood fires. Visitors can feast on buffalo burgers, chicken and noodles, barbecue, ham and beans, fish and chips cooked in big iron kettles, potato brats, apple dumplings, corn on the cob, apple sausage, and more, including ice cream, one of George Washington's favorite treats. Local clubs cook and serve these historic foods to fund their projects: Rotary, Kappa Delta Phi, Swingin' Dudes Square Dancers, Grass Creek Lions Club,

and Fulton County Historical Society. Beverly Jackson and Rochester, do the barbecue and sweet potato pie, and also exhibit a frontier African-American house. Many people come to the festival just for the delicious

The grounds are handicapped accessible. Free tram rides are available to bring people from the museum, round barn and Living History Village, which will be open, at the north end of the grounds.

Eddie Joe Mitchell &

Chief We-wis-sa was present at the 1837 treaty council at Lake Kee-wau-nay (now Lake Bruce), according to George Winter, frontier Indiana artist who sketched and later painted oil portraits of the Potawatomi. Wewis-sa signed three treaties in 1836 on the Tippecanoe River north of Rochester and went west in 1838 on the Trail of Death. He signed two treaties in Kansas.

While on the Trail of Death

Indiana to Kansas last fall, we stopped at the marker in Lafayette that noted Chief Wewis-sa's mother died there at the age of 100 on September 12, 1838, on the Trail of Death. Eddie Joe Mitchell, Prairie Band, traveling with the caravan, recognized the name We-wis-sa as being a name in his family. So, we asked him to represent the Chief We-wis-wa family at the Trail of Courage this year.

Eddie Joe traveled with his wife's brother, Thomas Wabnum and son Marshall, on the Trial of Death caravan. He wrote about this in his blog on his website, www.reznjun.com. Eddie Joe will take part in the Chief

 100^{th} Menominee statue anniversary ceremony September 18 at 4 p.m. He will also attend the Trail of Courage Living History Festival, Sept. 19 and 20, selling and demonstrating his crafts. He will be the honored Potawatomi family at the opening ceremony and be presented with a key to the county by Fulton County Commissioner. Sherry Fulton. He will tell his family and tribal history from 10:30 to 11:00 a.m. both days of the festival. +++




inches in length, well above the 20 inch size limit for northerns.

Letter To The Editor...

Letter to the Editor:

I write in response to "Concerned Citizen" whose letter appeared in the Sept. 3, 2009 issue.

You raise some important questions and I am encouraged that a library user displays some concern for his/her local library. Due to space limitations, I will address only a few of your concerns.

As a former patron, then clerk, and lastly as Director of Kewanna-Union Township Public Library, I believe that I am qualified to respond to your comments and questions.

1. According to Indiana Code 36-12-2-21, public library Board of Trustee members serve without monetary compensation, with the exception of the Treasurer.

2. Public libraries are municipal corporations (IC 36-12-2-2) and are funded primarily through taxes. Municipal property corporations must adhere to federal and state laws, some of which are written expressly for public libraries.

3. Members of governing bodies of any municipal corporation at the local and state level may sign a "conflict of interest" form to work perform for said government unit. This is not uncommon, especially in small municipalities. (IC 5-16-11-2, 5.5)

4. I truly doubt that regular meetings are being held "in silence". Due to the sensitive nature of some meetings, municipal corporations may hold executive sessions that are not open to the public.

5. Library boards, and other government boards, are not obligated by state law to publish meeting minutes in the news media. This is done at the discretion of the board, and of the news media.

6. For 23 years, I was employed at the Rochester branch of the Fulton County Public Library system. Three years ago, that building underwent an extensive remodeling and expansion project - and we remained open during most of the construction period!

The addition was constructed first. When both the old and new areas were under one roof, the joint wall was removed, with heavy plastic sheeting forming the wall. Regular library business was able to be conducted, even with the light noise.

Were we bothered by dust? Only when we ventured around a barrier or under the plastic sheeting to sneak a peek at the vast new space did we notice dust.



When the new addition was ready, collections, equipment, furniture and employee stations moved into the new addition, allowing the old part to be remodeled.

Most of the A-V collections were made available to the public. About one-half of the Adult Non-fiction collection was boxed and stored in a neighbor's garage. Adult fiction remained on the shelves with employees stepping over power cords, walking around ladders and scaffolding to retrieve books for patrons, who were obviously not allowed in that construction zone.

When remodeling completed, we were closed for one week to move back into the remodeled, repainted and recarpeted area.

In retrospect, moving the entire library contents off-site (as Akron Public Library did) is certainly preferable, but not always feasible, during construction. As with any project, you get creative. you become flexible and you do the best you can for your patrons.

One final thought: My memories of working at the Kewanna Library are very
