KEWANNA TOWN COUNCIL

The Kewanna town council met in regular session Thursday, April 1, at 7 p.m. at the Kewanna town hall. Present were council members, Jeff Finke, Mark Smith and Dan Birge; clerk-treasurer, Jenny Kay; fire captain, Tony Pesaresi; marshal, Dennis Price, superintendent, Mike Molitor; assistant superintendent and his wife, Danny and Mary Chew; engineer, Van Janovic; and local resident, Charlotte Hartung.


Marshal Price submitted his monthly report noting two traffic arrests, three traffic warnings, four criminal arrests, 44 calls answered, one gun permit, two vehicle checks and 1.647 miles patrolled. He also noted that the cameras have been installed. The current system can only accommodate four cameras and the department would like to upgrade to a system that can accommodate eight. Marshal Price's radio has been sent in for repair. Due to the age of the radio, it is uncertain if the repairs will fix the problem. The council approved the upgrade to the camera system, as well as purchasing a new radio that will compliant with FCC Price regulations. Marshal meth awareness attended schooling at Grissom March 2. He and Deputy Jon Sailors attended state mandated classes at Grissom March 10.

Fire captain, Tony Pesaresi, submitted the fire report and inquired about the town's share of LOIT (Local Option Income funds. Additional appropriations from the LOIT funds will be advertised and a hearing will be held at the May The council meeting. department responded to three town alarms in March, one fire and two medical: and seven township alarms, three fire and four medical. Training pertained to ice rescue.

Van Janovic, engineer for the ground water tile project, submitted a change order for the construction of a manhole on the Winamac Coil Spring sanitary sewer lateral in the amount of \$11,479.7. The change order was approved. The council also signed a storm water easement as there were minor wording changes requested on prior paperwork.

Resident Charlotte Hartung expressed concern that semi trucks passing her residence will take out her electric and/or telephone lines. The electric lines have already been moved, but the telephone lines need to be moved higher. The clerk will contact Century Link concerning the problem.

Town superintendent Mike Molitor noted he had spoken with local resident Josh Martindale regarding a request he made to tie into the town's tile in the back of his property. The council agreed he could tie into the town tile if needed, but would have to repair his tile first. Molitor reported he has



Kallenbach announces candidacy for State Representative

Richard Kallenbach, DeMotte, has announced he will seek the Republican nomination for Indiana State Representative for the 16th District. Kallenbach, 64, is a graduate of Purdue University and the Indiana University School of Law. In 1986 he was appointed Jasper County prosecutor, a position he held until 1990. During his tenure as prosecutor, Kallenbach was appointed Special Assistant United States Attorney to investigate and prosecute drug trafficking in Northwest Indiana. He first opened a legal practice in Demotte in 1982 and is now senior partner in the Kallenbach, Burkhartt and Waddle law firm.

received a quote of \$3,800 from Alan Ash for some excess lab equipment he would like to purchase from the town. The council made a counter offer of \$4,000 based on what the equipment is worth according to Blue Book prices. The council agreed to repairs to a concrete structure and the purchase of a new muffin monster this coming summer for the wastewater treatment plant. No action was taken on Molitor's previous request to have the assistant superintendent work different hours during the storm water drain construction project.

The council and clerk are planning to clean, trim and mulch Toner Park on Main St. Saturday, April 24, at 1 p.m. Anyone in the community who would like to help is more than welcome.

The annual town wide clean-up day has been set for Saturday, May 22, from 8 a.m. to 1 p.m. Dumpsters will be located at 215 Maple St. for the clean-up project. This service is for residents of the Town of Kewanna only and operates on a first come, first serve basis. A list of items prohibited in the dumpsters will be published two weeks prior to the clean-up.

The town will be hiring summer mowing help. Applications can be obtained at the clerktreasurer's office.

Pay requests for the storm water drain construction project were approved for payment as were other claims against the town, water and sewage works.

Absentee voting for the May 4th primary election has begun. Eligible voters can cast an absentee ballot in-person with a federal or Indiana-issued photo ID at the county clerk's office.

The State Budget Agency announced Monday that state revenue collections increased in March for the first time in 17 months. Tax collections were \$908 million, or \$7 million above collections for the same period last year. But year-to-date collections are still \$867 million below the amount forecast last May.

The Indiana Department of Child Services has established a child abuse hotline for the reporting of suspected child abuse and neglect. The hotline number is 1-800-800-5556. The central intake facility will be staffed 24/7 all year round with specialists trained to ask the right questions to get the appropriation information from salad, potato soup, peas & residents calling the hotline carrots, applesauce, crackers number.

The Logansport Community School Corporation is closing the Landmark Adult Learning Center at the end of this semester. As a result, Rochester and Kewanna will lose its GED program. Local resident, Bev Kreamer, has been teaching GED classes here and in Rochester (including the Fulton County Jail) since 1985.
