### Town council to discuss local health care

The Kewanna town council will meet with representatives from the Regenstrief Center for Healthcare Engineering (RCHE) based at Purdue University at 6 p.m. Tuesday, January 22, at the town hall, 308 S. Logan St., Kewanna. They will be discussing the status of health care options in the area. This meeting is open to the public as are all meetings of the town council.

The Regenstrief Foundation was created by Sam and Myrtle Regenstrief in 1967 to promote the application of engineering and production concepts to healthcare delivery. Recognized as an authority on industrial production techniques, Sam Regenstrief believed that these concepts would provide better healthcare at lower cost. The Regenstrief Foundation solicited proposals from several universities to develop a new research center that would translate research in engineering, science and management into recognizable, long-term transformation of healthcare. Purdue University was awarded financial support for three years to establish the Regenstrief Center for Healthcare Engineering in January 2005.

### Eighth grade orientation

An orientation meeting will be held Tuesday, January 22, at 7 p.m. in the socialtorium for all parents of prospective freshmen at Winamac Community High School. The meeting will deal with scheduling of classes for next year.

Mrs. Daily, the high school counselor, will go over graduation requirements that the students will need to complete over the next four years. She will also be discussing how to fill out the students' four-year plans for the tri-mester scheduling system.

This meeting is very important and all parents are encouraged to attend.



The Lake Bruce Conservancy District held its regular monthly meeting Thursday, January 10, in the community room of the Kewanna-Union Township Fire Station. Four of the five directors were present as well as 14 freeholders and two guests.

The minutes of the previous meetings were approved as was the treasurer's report. Chairman Norm Steigely covered the correspondence received during the month.

Treasurer Rick Tompos outlined the contract with Quality Assurance, Inc., the company that will prepare the sewer bills for the district. He stated that they have agreed to reduce the billing charges from \$5 per bill to \$4.20 per bill, as the district had estimated in its preliminary planning. The duration of the contract was also reduced, from five years to two years. The board unanimously approved the contract. Rick mentioned that the first bill may not be sent out until February, but the bill will be for two months, January and February.

The options purposed for vacant lots were discussed. Since a connection fee of \$6,300 will be charged for any connections to the sewer system after the initial project is completed, any freeholder with a vacant lot has the option to connect now and pay the monthly debt service charge of \$46.88. If a person is planning to build on a vacant lot, they may want to exercise this option. A form was approved for people to notify the district of their intentions. It was suggested that this form be inserted into the first billings to make sure everyone is aware of the option. Persons receiving the forms that have a vacant lot but do not intend to use the option should check the proper box and return the form.

Tompos reported on the loan closing that took place with Rural Development December 20. He mentioned that Rural Development required the issuance of checks to contractors within 10 days of receiving the monies from them. A resolution was approved by the board to allow him to pay the contractors as the bills come due rather than waiting for the regular monthly meeting.

Steigely read the Sewer Use Ordinance 2008-1, which was approved by the board. This ordinance will be put on the district's web site, [www.LBCD.info](http://www.LBCD.info), in the near future.

Steve Fralish of Wightman-Petrie gave his monthly progress report. He noted that the pre-contractor meeting was held earlier in the day with two

contractors, Rural Development, Wightman-Petrie, two LBCD board members, NIPSCO, REMC and telephone company representatives in attendance. The pipeline contractor stated that he had to be done laying the pipe by October, but that the restoration of yards may not be finished until spring. This will be determined by the weather. Fralish also delivered signed contracts from Kamphuis Pipeline Company and Thieneman Construction to the district. Wightman-Petrie also presented the resumes of two people to act as inspectors for the district. The applicants, Josh Thomas and Carl Mosser, both have extensive experience and were unanimously approved by the board. Fralish also reported that once construction starts, a monthly meeting must be held to approve payment for work that has been completed. This meeting will be held the second Wednesday of the month at 10 a.m. The board unanimously approved a resolution giving any member of the board authority to approve the payment requests.

Steigely reported that the district had received only three completed nomination forms by the December 1 deadline for the three director seats that will become open February 2008. These forms were from Richard Tompos, Kathy Fisher and Brad Glasson, all current officers. He also reminded everyone that elections will take place Thursday, February 21, from 1 to 6 p.m. The annual meeting will take place at 7 p.m. the same day. Fred Gilsinger, Barb LaFollette and Barb Steigely have agreed to be poll workers for the election.

Lake Enhancement Chairman Gerald Porter gave a report. He went over the five-year plan that was submitted to the Department of Natural Resources (DNR). He also noted he had received an application for membership in the Lakes Management Association. He stated that he had been to a few meetings they had put on and they were very informative. He also reported that membership will also give the district access to valuable information on lake enhancement. The board voted to approve the cost of \$50 for membership in the organization and \$70 for registration for Porter to attend the group's annual meeting.

Steigely reported that the domain name of [www.LBCD.com](http://www.LBCD.com) is up for renewal at a cost of \$7.99. The one-year renewal for hosting the site is also coming due at a cost of \$140.25. The board voted to allow Steigely to pay both fees with his credit card when they come due and turn the cost in for reimbursement.

Steigely reported that Attorney Stephen Studer is working on getting everything ready for closing on the Rude property. The board gave the treasurer authority

**Free tetanus shots**

The Fulton County Health Department is offering free tetanus shots to those individuals who reside in areas recently affected by the flooding and any individual who has assisted EMA, fire and rescue, and any other emergency agency during this time. Proof of residence or assistance with one of these emergency agencies is required in order to receive the tetanus shot free.

After the flood, water may not be safe to drink. Therefore, the Indiana Department of Environmental Management recommends that property owners concerned about the quality and safety of their water do one of the following: (1) use bottled water; (2) boil their water for at least five (5) minutes. The five minute time frame begins when the water has come to a rolling boil.

Any individual residing in areas affected by the recent flooding

can pick up a kit to test their well water for free at the Fulton County Health Department. Proof of residency is required to obtain the test kit. The Indiana State Health Department is covering all costs associated with testing these wells.

For the most accurate test results, it is best to test wells after the flood waters have receded. Office hours for the health department are Monday through Thursday 8 a.m. to 4 p.m. and Friday 8 a.m. to 5 p.m. Further questions and information can be obtained by dropping by or calling the health department at 574-223-2881.

It is recommended that those individuals residing in the flooded area have their septic tank pumped out and limit their water usage. Steps that people can take to limit their water usage include, but are not limited to, taking your laundry to a laundromat, taking short showers, etc.

Information regarding what steps one needs to take to clean up after the flood can be picked up at the health department, 129 E. 9<sup>th</sup> St. or the Fulton County Emergency Management Agency, 1728 E. State Road 14, Rochester.

to request the necessary monies from Rural Development (approximately \$20,000) and then write a check to close on the property when the closing is held.

He also reported that it is important to get service from the utility companies as soon as possible and that to do that the district must get addresses for the sites to be serviced from both counties' (Fulton and Pulaski) 911 administrators. Norm also reported that he will be moving in the near future and that office space for the district can no longer be located in his home due to space limitations. Discussion took place on the possibility of renting a trailer to house the office. The cost of this must be investigated and will be reported on at the next meeting.

The meeting adjourned at 8:55 p.m. The next monthly meeting will also include the annual meeting and will be held at 7 p.m. Thursday, February 21. The meetings are open to all freeholders and interested parties.

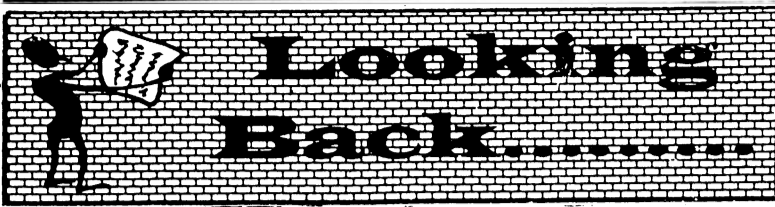


