Trail of Courage, September 20-21

You can step back in time to an entirely different life when frontier Indiana history walked the streets at the 33rd annual Trail of Courage Living History Festival Saturday and Sunday, September 20 and 21 near Rochester. The Potawatomi Indians were marched single file down Rochester's Main Street September 5, 1838, on the forced removal of the Indians from this area, known as the Trail of Death. Since 1976, this festival has honored the American Indians and shown life before the removal when this was still Potawatomi territory.

Frontier Indiana comes alive with foods cooked over wood fires, period music and dance, traditional crafts, historic camps and trading, canoe rides on the river, and much more. The festival is produced by the Fulton County Historical Society. This event combines genealogy of the Potawatomi Indians and the settlers who lived in Fulton County and northern Indiana in the early 1800s with the rendezvous events, stage programs, historic canoe landing and fur trade skit on the Tippecanoe River. The Trail of Courage is staged on the FCHS grounds four miles north of Rochester on U.S. 31. Admission is \$6 for adults, \$2 for children 6-11, and free for children age five and under. Hours are 10 a.m. to 6 p.m. Saturday and 10 a.m. to 4 p.m. Sunday.

This year's honored Potawatomi family will be descendants of Abram Burnett, Tracy Locke and her 10-year-old daughter, Erin Locke, of Lafayette will tell their story at 10:30 a.m. on the Chippeway Village stage both days. The Trail of Death Caravan will leave Chief Menominee's statue at 9 a.m. on Monday, September 22, and retrace the route taken by the Potawatomi in 1838. To register to travel with the group, see their Website at www.potawatomi-tda.org. Members of the Citizen Potawatomi Nation, Shawnee, Oklahoma, have received a grant to make a documentary so they will be traveling with the group this year. Also, John Bowes from the Smithsonian will come to gather materials for an exhibit on the Trail of Death for the National Museum of the American Indian.

New this year at the festival will be D3 Fife & Drum from Detroit, Michigan; Ben Franklin portrayed by Chuck Molenda of Carpentersville, Illinois; Marsha Glassburn, Rochester - storytelling; Thistle Mountain of Leo - dulcimer music; and author John McMullen of Evansville, author of *The Last Blackrobe of Indiana*.

The public is invited to join in the Indian dances at 2 p.m. and 3:30 p.m., which are held in an arena encircled by teepees. The drum will be Massassagan Drum led by Mike Floyd, chief of the

Eel River Tribe. Head dancers will be Glenn and Beverly Barnhill of Bloomington. Beverly is a member of the Prairie Band Potawatomi and Glenn is Lakota. George Godfrey of Athens, Illinois, member of the Citizen Potawatomi Nation, will act as emcee. He is president of the Potawatomi Trail of Death Association and has been dancing at the Trail of Courage since 1988. Godfrey had an ancestor on the 1838 Trail of Death.

The Trail of Courage includes historic encampments representing the French and Indian War, Voyageurs, Revolutionary War, War of 1812, Western Fur Trade, Plains Indian teepees, and a Woodland Indian wigwam village. A special re-creation of a Miami Village includes wigwams and life ways demonstrations such as making cattail mats. There is also a re-creation of Chippeway, the first trading post, post office and village in Fulton County in 1832. Food purveyors and traditional craftsmen set up in wooden booths to demonstrate and sell their wares. Craftsmen also sell pre-1840 trade goods from blankets and in historic merchant tents offering a variety of items from clothing and jewelry to knives and candles, everything needed to live in frontier days. Canoe rides, muzzle loading shooting and tomahawk throwing contests and a frontier blab school add to the frontier activities.

Two stages with frontier music and dance present programs from 10 a.m. to 5 p.m. Saturday and 10 a.m. to 4 p.m. Sunday. Since the early 1980s, FCHS has received grants from the Indiana Arts Commission and the National Endowment for the Arts to help pay for musicians and dancers including the 42nd Royal Highlanders, D3 Fife & Drum Corp, Aztec Dancers, Shakin' Hammers String Band, Mark and Liza Woolever, Thistle Mountain, Steve McPhail as Johnny Appleseed, Chuck Molenda as Ben Franklin, Kim Hoover of Hoots to Howls Wildlife

Rehabilitation, Chief White Eagle with his Indian lore, Indian dancers and drum. Many volunteers provide programs such as the Frontier Frolic dance called by Shirley Willard; Nan Edwards' dogs pulling travois; the Schultz family goats and kids; Marsha Glassburn and her Indian storytelling; Riddle School fourth grade dancers; Hannah Jones on the fiddle; and Mark Gropp on the bagpipe. Both Catholic and Protestant worship services are held at 9 a.m. on Sunday.

Pioneer foods are cooked over wood fires. Visitors can feast on buffalo burgers, chicken and noodles, barbecue, ham and beans, fish and chips cooked in big iron kettles, potato tarts, apple dumplings, corn on the cob, apple sausage, and more, including ice cream, one of George Washington's favorite treats. Local clubs cook and serve these historic foods to fund their projects including the Rochester Rotary, Kappa Delta Phi, Swingin' Dudes Square Dancers, Grass Creek Lions Club and the Fulton County Historical Society. Harvey and Beverly Jackson serve barbecue and sweet potato pie and also exhibit a frontier African-American home. Many people come to the festival just for the delicious food.

The grounds are handicap accessible. Free tram rides are available to bring people from the museum, round barn and Living History Village at the north end of the grounds to the festival site. The museum and village are open with costumed hosts and free admission.

Volunteers can earn free admission to the Trail of Courage by working half a day. To volunteer or for more information, call the museum at 574-223-4436. Free parking is provided on the FCHS grounds and there are plenty of benches available to sit and rest.

The News In Brief

Judy Reed, Fulton County treasurer, reports that tax statements should be in the mail the week of September 15. The spring tax installment will be due October 15, 2008 and the fall tax installment will be due November 26, 2008.

All Fulton County government offices will be closed Monday, September 1, in observance of Labor Day.

The Fulton County Commissioners have signed a memorandum of understanding for the former Rochester post office building. The county plans to use the facility to house the county sheriff's administrative and dispatch offices. The county will lease the building for \$4,400 per month with an option to purchase.

The Farmers Almanac predicts below average temps for most of the U.S. next winter. The almanac also predicts above normal snowfall for the Great Lakes and Midwest during January and February.

The Kewanna-Union Township Public Library will be closed Monday, September 1, in observance of Labor Day.

Due to requirements of the budget advertising process, the Lake Bruce Conservancy District's regular September meeting has been postponed from the 11th to the 18th.

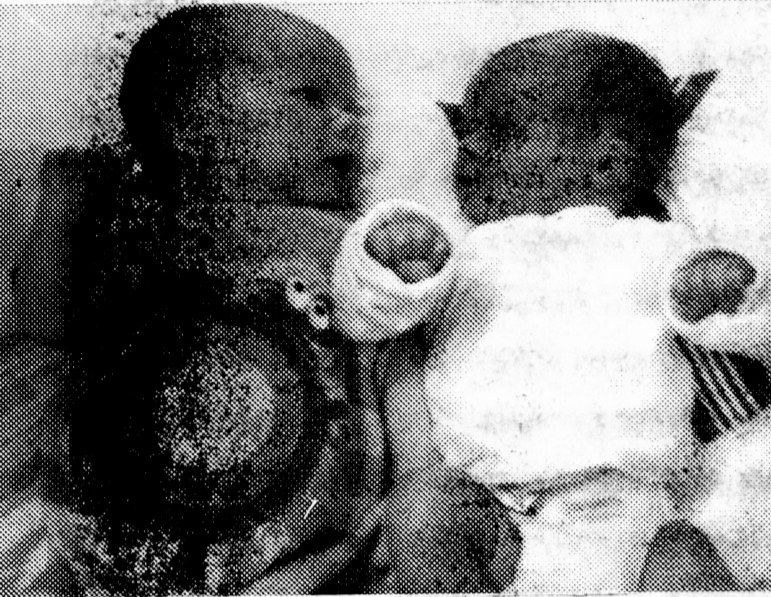
County Board of Commissioners, is doing the hauling.

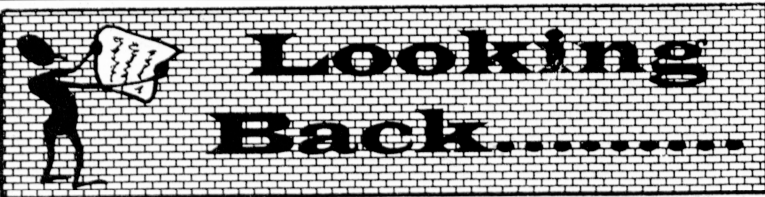

Annual asbestos report

The Asbestos Hazard Emergency Response Act (AHERA) requires that schools report the status of asbestos in their facilities each year.

Pulaski Memorial gets new imaging equipment

Once again, the Pulaski Memorial Hospital Imaging Department is leading the way in non-invasive imaging with the purchase of the General Electric Dual Energy X-ray Absortometry (DEXA), according to Karen Brown, Director of Radiology.

"DEXA scanning is currently the most widely used method to measure bone mineral density because it more precisely documents small changes in bone mass and is also more flexible since it can be used to examine both the spine and the extremities," Brown explained.

A scan of the spine, hip or total body requires only one to four minutes. DEXA scanning is less expensive, exposes the patient to less radiation and is more sensitive and accurate at measuring subtle changes in bone density over time or in response to drug therapy.

DEXA uses two X-ray beams with differing energy levels aimed at the patient's bones, and is the most widely used and most thoroughly studied bone density measurement technology.
