Morris Mott in concert at Methodist Church





FIFTY-FIVE YEARS AGO October 2, 1953

John Leeds, who lives east of Kewanna, has a copy of the Ulster County Gazette (Kingston, NY) for January 4, 1800. The paper, which is enclosed in a glass case, is one of the most valuable newspapers of early America as it contains the first obituary of George Washington who died in December of 1799.

For the next few weeks, inspection crews will be conducting a physical survey of the Kewanna sanitary sewer system. This study will involve the opening and entering of manholes in the streets and easements. An important task of the survey will be the "SMOKE TESTING" of sewer lines to locate breaks and defects in the sewer system. The smoke that you see coming from the vent stacks on houses or holes in the ground is NON-TOXIC, HARMLESS, HAS NO ODOR AND CREATES NO FIRE HAZARD. The smoke should not enter your home unless you have defective plumbing or dried up drain traps. If this occurs, you should consult your licensed plumber. In any event, if the harmless smoke can enter through faulty plumbing, the potential exists for dangerous sewer gases to enter your home. Should smoke enter your home, you may contact a member of the smoke testing crew working in the area and he will be pleased to check with you as to where and why the smoke has entered your home. If you have any seldom used drains, please pour water in the drain to fill the trap, which will prevent sewer gases or odors from entering the

Some sewer lines and manholes are located on the backyard easement property lines. Whenever these lines require investigation, members of the inspection crews will need access to the easements for the sewer lines and manholes. Homeowners do not need to be home and the workmen will not need to enter your house.

Photographs are to be made of leaks occurring in the system. We anticipate the smoke testing will require approximately one (1) week in your area. Your cooperation will be appreciated. The information gained from this study will be used to improve your sewer service and may reduce the eventual cost to taxpayers.

Home Escape Planning and Practice

Letter to the Editor

If a fire broke out in your home, do you know how much time you would have to get out? Unfortunately, no one knows for sure. While most people feel safe in their homes, the reality is that home fires are much more common than you might think. There were nearly 4,300 home fires reported in 2007 in Indiana, resulting in approximately 100 Hoosier deaths.

In a perfect world, we would be able to prevent all home fires. In reality, we can be vigilant, but there are no guarantees. Any emergency can affect one's ability to think clearly, but during a fire, smoke and other physical factors can literally inhibit your ability to

The theme for Fire Prevention Week (October 5-11, 2008) this vear is "Prevent Home Fires," and focuses on preventing the leading causes of home fires - cooking, heating and electrical equipment, and smoking materials.

While the statistics are daunting, most home fires are easily preventable when we narrow our focus and take personal steps to increase our safety. Working smoke alarms and fire escape planning and practice are integral to keeping your family safe, but another element that you may want to add to your safety system is home fire sprinklers. Because they react so quickly, fire

sprinkler systems can dramatically reduce the heat, flames and smoke produced in a fire. When sprinklers are present, the chances of dying are reduced by more than one-half and the average property loss per fire is cut by one-third to twothirds, compared to fires where sprinklers are not present.

There are also a number of simple steps that you can put into action to keep your home safe from fire:

- Cooking: Stay in the kitchen when you are frying, grilling, or broiling food. If you leave the kitchen for even a short period of time, turn off the stove.
- Heating: Keep all things that can burn, such as paper, bedding or furniture, at least 3 feet away from heating equipment.
- Electrical: Replace cracked and damaged electrical cords; use extension cords from temporary wiring only. Consider having additional circuits or receptacles added by a qualified electrician.
- Smoking: if you smoke, smoke outside; wherever you smoke, use deep, sturdy ashtrays.

Preparing for the unexpected is difficult, but when it comes to home fires, minutes, even seconds. can mean the difference between life and death. That's why having a well-practiced fire escape plan is vital to the safety of your family.

To get you and your family started in planning a home fire escape, follow these tips:

- · Install a smoke alarm on every level of your home and have one inside each bedroom and outside of each sleeping area. For the best protection, interconnect alarms so that when one sounds, they all sound.
- Test smoke alarms at least once a month.
- Replace batteries in smoke alarms at least twice a year. Plan on replacing the batteries when you change your clocks for daylight saving time.
- · Develop a fire escape plan that identifies two ways out of each room and a family meeting place outside. Once outside, never return inside the house.
- Make sure your plan allows for any specific needs in your household. If everyone knows what to do, everyone can get out quickly.
- Practice using the plan at least twice a year.
- Some children and adults may not awaken to the sound of the smoke alarm. Designate someone to wake up each person in the household.
- Remove any items that may block doors or windows in your home. Make sure when arranging furniture and other items that you're not blocking doors or windows. They could keep you from escaping in the event of a home fire.
- Be sure to remove a pile of toys or other items in front of a doorway that can block your escape route and be a threat to the safety of you and your family.

We want to encourage all Hoosiers to be prepared. Currently, only 35% of U.S. households have a well-practiced plan in place for escaping home fires. The Indiana Department of Homeland Security and the State Fire Marshal encourage families to make a fire escape plan and practice it. Fire is unpredictable, but preparation in the form of a well-practiced escape plan can help keep you and your family safe, and potentially save

cells that were lost during treatments such as chemotherapy and radiation.



Holiday mailing

While the first signs of autumn may yet to appear, it's not too early to start thinking about holiday cards, letters and packages destined for service members and their families stationed in faraway lands. According to the Kewanna post office, the first deadline for the 2008 holiday season is about 60 days away.

Thursday, November 13, is the deadline for sending holiday packages to troops stationed

overseas using parcel post to all Air/Army Post Office (APO) or Fleet Post Office (FPO) ZIP codes.

"The U.S. Postal Service is encouraging early deadlines," said Kewanna officer-in-charge Karen Troxell, "to ensure packages reach their destination in time for the holidays."

All military mail, regardless of destination, is sent by domestic mail rate. International rates do not apply to military mail delivery.

One way Hoosiers can confirm delivery is by using Delivery Confirmation, available for almost all military destinations outside the U.S. Delivery Confirmation provides customers with the date, ZIP code and time the package was delivered. This information can be accessed online at www.usps.com.

"Mail is one of the greatest morale boosters we can give our soldiers, sailors, marines, airmen and coast guardsmen during the holidays," said Troxell. "When they see packages or letters waiting for them it brings them that much closer to family and the comforts of home."

The U.S. Postal Service also has a Military Care Kit to make it easier for military families and friends to send packages to servicemen and women and their families stationed overseas. Each free kit contains three flat rate boxes, two cube boxes, nine address labels, and 16 customs forms. The kit may be ordered by calling the USPS Expedited Package Supply Center at 1-800-610-8734.

"Another good deal," said Troxell, "is the Priority Mail Large Flat-Rate Box introduced earlier this year. It offers a \$2 discount to APO/FPO destinations and ships for \$10.95. Go online, used Click-n-Ship and the price drops to \$10.50."

The U.S. Postal Service has also made celebrating the holidays more personal by making it as fun and easy as baking holiday cookies.

"With a little creativity, customers can create their own holiday cards and customized postage on first-class mail, Priority Mail and Express Mail," the Kewanna officer-in-charge added. "It's all available at www.usps.com."

All packages and mail must be addressed to individual service members, as required by U.S. Department of Defense regulations. "We cannot accept any mail addressed to 'any service member' "Troxell added.

The U.S. Postal Service places APO/FPO mail on special charter flights, commercial airlines and military service aircraft to reach armed services members overseas as quickly as possible.






