Town council convenes in regular session

The Kewanna town council met Thursday evening, October 2, at the town hall for its regular monthly session. Those present included council members Jeff Finke, Dan Birge and Mark Smith; Jenny Kay, clerktreasurer; Tony Pesaresi, Mike Molitor, Dennis Price, Cliff Bragdon, Tom Mate, Mark Hall of Thieneman Construction and Diane and Rick Hurtt.

Tony Pesaresi gave the September fire report noting that the local department responded to five town alarms (one fire and four medical) and seven township alarms (one fire and six medical). Training involved hose testing. He also provided a list of the fire vehicles and their mileage at the request of Councilman Smith. Lastly, he thanked Tom Mate for a job well done with this year's Kewanna Fall Festival.

Marshal Dennis Price submitted his September police report with a request to hire Jon Sailors, Jr. as a reserve on the Kewanna Police Department. After reviewing Sailors' application and resume, the council okayed the hire. Price also mentioned there was no criminal activity during the recent fall festival. During September, the department made one traffic arrest, issued three traffic warnings, made two criminal arrests, made five accident reports, answered 52 calls, performed one vehicle check, and patrolled 1,415 miles.

Tom Mate, head of the Kewanna Fall Festival committee, gave a report on this year's event and thanked the various departments for all the effort put forth in helping to make this year's festival a success. Some plans were shared for next year's event, which will take place September 25, 26 and 27.

Rick and Diane Hurtt shared their plans to install a geothermal heating system in their home. This would involve digging a well just for that purpose. The council approved the work, noting a permit would not be needed for this work but suggested the Hurtts contact the State Highway Department for approval of emptying into their drain tile, as it does not belong to the town.

Town superintendent Mike Molitor and Mark Hall discussed the progress on work at the sewage treatment plant. The council approved a change order allocating \$37,000 to remove 250,000 gallons of sludge from the west lagoon. Anything over the 250,000 gallons will be billed at \$.14 per gallon.

The town superintendent's monthly report noted meetings with the engineer and contractor for the upgrades at the sewage treatment plant to determine a starting date and change orders. He also met with the contractor hired to smoke test the town's

sewage collection system. Molitor and town employee Danny Chew attended an all-day seminar at Grissom Air Base. Twenty-five new water meters were installed during the month and couple of trees were cut and hauled away. Mike was in touch with the Department of Natural Resources concerning the mud puppies at the sewage treatment plant. The DNR officials performed a survey of the critters and determined that there are five species of tiger salamanders at the treatment plant. They felt that the salamanders would not create a problem, except when they get in the contact tank and then end up in the irrigator. They recommended putting something over the pipes to keep the salamanders out. Molitor checked around and found a company that would make five stainless steel screens at a cost of \$400 each. However, with the help of Plymouth Tube and Winamac Coil Spring, he has determined that he can make the screens himself, at considerable cost savings. The town borrowed the county's broom to clean the streets and town lot for the fall festival. Danny Chew swept the sidewalks along Main Street. The town's valve cleaner was then used to suck up the dirt. Molitor noted that he is probably done irrigating for the season as the town's sewage treatment lagoons are down to about one foot in depth. The contractor in charge of replacing the liners on the lagoons can remove remaining. The water works pumped a total of 1,158,800 gallons water during September.

A proposed budget for the water works was okayed by the council and forwarded to USDA Rural Development, which financed the latest improvements made to the water system in the late 1990s.

A hearing was held on the 2009 budget, with no comments offered. The council will meet in special session at 7 p.m. Monday, October 13, to adopt the budget.

Claims against the town, water and sewage works, including construction claims, were approved for payment.

Enrollment begins for winter warmth

program

MERRILLVILLE, Ind. – Northern Indiana Public Service Company (NIPSCO) announced its Winter Warmth program, in conjunction with state and federal Low Income Home Energy Assistance Program (LIHEAP), is open for enrollment to eligible natural gas customers.

"In preparation for higher natural gas prices this winter, we are pleased that enrollment for the Winter Warmth program is opening earlier this year," said Cynthia Jackson, energy assistance and weatherization program manager for NIPSCO. "The Winter Warmth program will continue to be a vital tool in assisting customers with their winter heating bills, and enabling families to stay safe and warm during the winter."

The Winter Warmth program is an energy assistance program designed to supplement existing state and federal energy assistance programs such as the LIHEAP program, which recently passed legislation to receive double the amount of funding this year.

Since the program's inception in 2004, Winter Warmth has provided nearly \$19.6 million in bill and deposit assistance to 48,733 customers.

Qualifying customers will be eligible to receive up to \$450 in annual energy assistance, and eligibility requirements include those customers up to 200% of the federal poverty guidelines, in addition to those who have a financial hardship situation as determined by an administering Winter Warmth agency.

This year, NIPSCO will increase its contribution amount toward the program to 18 percent of total dollars collected from customers for the 2008-2009 winter heating season. The average residential customer will contribute

approximately \$0.63 per month toward the program.

Qualifying customers may begin applying for the Winter Warmth program and state and federal energy assistance by visiting one of the 31 existing energy assistance agency sites located across NIPSCO's northern Indiana service area.

As always, any customers who are experiencing trouble paying their bill are urged to contact NIPSCO before the bill is due in order to provide ample opportunity to work together and explore what options may be available.
