## Metzgers donate flags

JoAnn and Max Metzger of Royal Center have donated a United States flag to Caston Schools inscribed with the names of all 2,998 persons who lost their lives in the 9/11 terrorist attacks. Caston principal, Doug Olsson, is shown here with the Metzgers as the flag was presented to the school last Friday. The flag will be hung in a hallway so the names of those memorialized can be seen by students, faculty and The Metzgers also staff. presented a flag to the Pioneer School Corporation.

The flags were secured through Homesteaders Life Insurance Company of West Des Moines, Iowa, the company the Metzgers used to fund pre-arranged funerals through Harrison-Metzger Funeral Homes.

The flag project began back in 2005 when Homesteaders Life, which has approximately 6,000 funeral home customers, was preparing to celebrate its 100th anniversary in 2006. company decided to recognize the 5th anniversary of the 9/11 terrorist attacks, which occurred September 11, 2001, by creating a Healing Field on its 17acres campus in West Des Moines. The creation of the Healing Field was a year-long process involving volunteers. The result was a field of 2,998 flags. Attached to each flag pole was a yellow ribbon bearing a name of a 9/11 victim.

Homesteaders Life then offered the flags to its customers, asking them to make a donation to a charity. Max and JoAnn received the last two flags available and had them framed for hanging by a Royal Center craftsman, Leslie Kistler. The releasing of the flags to its various customers raised \$50,000 for two different charities, the Funeral Service Foundation and Hospice of Central Iowa, and well as various other local charities. The Metzgers made donations to the Lions Club International Foundation, United Methodist Children's Home and Memorial Hospital Foundation.

Cummins Engine, headquarted in Columbus, Indiana, has agreed to buy up to \$25 million in stock of Irwin Financial Corp., a Columbus based bank holding company. Irwin says it also has \$6 million in commitments from other investors, including its chairman and former Cummins CEO Henry Schacht.

All Fulton County government offices will be closed Tuesday, November 4, for Election Day.

Plymouth officials are proposing to trade its current airport to the state in return for using a portion of U.S. 31 as a runway when the new U.S. 31 connecting South Bend and Indianapolis is completed. The airport buildings could house a highway department facility and the City of Plymouth would not have to expand the existing tarmac. Groundbreaking for the new route connecting South Bend and Indianapolis was held this month.





#### FIFTY-FIVE YEARS AGO October 23, 1953

The Grass Creek School was entered Wednesday night, October 21, and \$5 or \$6 was stolen from the Coca Cola vending machine. Aside from the machine money, there was nothing missing that could be checked, although the principal's office and the storeroom were entered and riffled.

The Grass Creek fire department answered a call Monday to extinguish a fire in a corn field on the Alpha Hoesel farm near here. Mr. Floyd Thomas was burning stumps when the fire got out of control and spread to the cornfield. About three or four acres of corn was burned before the fire was brought under control.

The Kewanna fire department was called to the Theodore Sunday Carlson farm extinguish a small fire along the railroad right-of-way. The origin of the fire is not known. Slight damage was done when the fire spread to a corn field, but it was soon brought under control.

Joe Herd, 19, was accidentally injured about 8 a.m. Wednesday morning by a blast from a shotgun which he was carrying on his corn picker. The gun discharged, hitting him in the foot. The mishap occurred on his parent's farm southwest of Kewanna.
