

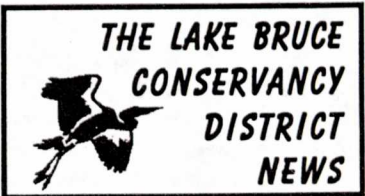

The Lake Bruce Conservancy District held its regular monthly meeting Thursday, November 13, in the community room of the Kewanna-Union Township Fire Station. All five directors were present as well as 15 freeholders of the district and four guests.

The minutes of the previous meetings and the treasurer's report were unanimously approved. Chairman Norm Steigely covered the correspondence received during the month.

The board finally made contact with Joe Rude about having him farm approximately 1 to 1½ acres around the treatment plant so the district would not have to maintain the land. He has indicated the he is interested and a contract will be drawn up for both parties to sign.

The district will have to have additional talks with DTI, the successful bidder on Phase 2 of the dredging project, as the company did not include some items in the quote. The board needs to know what the additional cost may be prior to having them perform any work. The chairman will contact DTI in the coming week to get the answers to the board's questions, then report back to the board of directors.

The board made final approval to the sewer connection ordinance and the sewer rate ordinance for extending the date a home owner has to hook up to the new system. Under the revised ordinances, properties must be hooked up by May 31, 2009, and may petition the board for a one-time hardship extension of 30 days. Copies of both ordinances will be on file at the Kewanna-Union Township Public Library for inspection purposes.

The district is ready to start hook-ups. A new set of coupon books for 2009 will be sent out with one for the December bill (due in January) reflecting the full rate of \$73.50. All contractors that have shown an interest in doing hook-ups have been notified that hook-ups may begin.

The procedure for hook-ups include:

1. Homeowners must call 811 to have utilities marked prior to starting any work. They will ask for the name and address of the contractor doing the work. (Note: it takes 2-4 days to have utilities marked.)

2. Fill out your application and give it to the private contractor you choose to do your work along with a \$75 check made out to the Lake Bruce Conservancy District.

3. The contractor will take the application and check to the district's inspector and get the permit, which must be displayed

before any work can be done.

4. The contractor and inspector will schedule when the work will be done and inspected.

5. Once inspection is passed, the homeowner can start using the new sewer system.

6. The contractor will then schedule the abandoning of the current system and restoring the lawn.

Discussion took place about the landscaping needed around the treatment plant and west vac station as well as the need to install some walk ways at the treatment plant. Contractors will be contacted to give quotes on installing two walk ways at the treatment plant. The board is not sure if it wants concrete or patio block. Director Gerald Porter and the operator, Richard Denney, will take measurements next week so the district can get quotes.

Other matters discussed included a quote from Accu-Dig for locator service. Their quote was about four times higher than SM&P so the board rejected the quote.

Gerald Porter gave the lake enhancement update. He stated he has talked with the Department of Natural Resources and will submit a LARE grant application for weed control in 2009. He also said he thinks the chance of getting a LARE award next year is unlikely so the district will probably have to pay the entire cost of weed control again in 2009.

Director Kathy Fisher gave a report on billing procedures she received at the regional sewer district meeting.

Chairman Norm Steigely introduced a motion to pay the Hoosier Hide Away \$100 for the use of its meeting hall to hold eight meetings between the district, engineers, contractors and Rural Development. The motion was unanimously approved.

At the request of a freeholder on Guise Park Road, pictures were taken by Wightman-Petrie and will be compared to the video taken prior to construction to determine if the break up of the road was caused by the construction company.

The subject of late charges was discussed at length as a freeholder requested relief due to the post office returning a payment because it was improperly addressed. The board was in unanimous accord that any payment received after the due date would be charged the late fee as per the sewer ordinance. The board does not want to make exceptions to the ordinance due to freeholder error.

Directors Norm Steigely, Gerald Porter, Kathy Fisher and Rick Tompos attended the monthly meeting with the contractors and engineers for approving payment of work completed during the past month. Bills approved included \$83,124.50 to Thieneman Construction and

Holiday stamps available

Four different nutcracker designs, the tender relationship between mother and child and a prayerful gesture by a young boy will help deliver joy this holiday season according to the Kewanna Post Office.

Santa, a king, a military captain and drummer comprise the Holiday Nutcrackers commemorative stamps and the *Virgin and Child with Young John the Baptist* painting by Italian master Sandro Botticelli - these stamps join the 2008 holiday stamp lineup which include the Eid Muslim holiday stamp; Kwanzaa celebration of family, community and culture stamp; and Hanukkah Jewish Festival of Lights stamp.

"We're pleased to add the Nutcrackers to our stamp program," said Kewanna Officer-in-Charge Karen Troxell. "As these stamps start to land in

mailboxes around the world, they're sure to add a glimmer of sparkle to the holiday season."

Nutcrackers have been around for centuries. During the winter holiday season, nutcrackers of all shapes and sizes are familiar sights in toy stores and marketplaces. Four eye-catching nutcracker designs are featured on the stamps.

Santa or "Father Christmas" has a lantern in one hand a snowflake-topped staff in the other. There is a gold and ruby-crowned king, a yellow-jacketed military captain, and a green-garbed drummer with a red drum.

The theme of the Christmas stamp has been the Madonna and Child since 1978. This year's design has an added twist with the additional figure of John the Baptist. The painting, tempera and oil on wood, by Botticelli dates to around 1490 and is now part of the world-renowned

collection of the Cleveland Museum of Art. Although cropped to fit the stamp format, *Virgin and Child with the Young John the Baptist* is painted within a round format, or tondo, a popular shape in Italy in the 1400s and 1500s.
